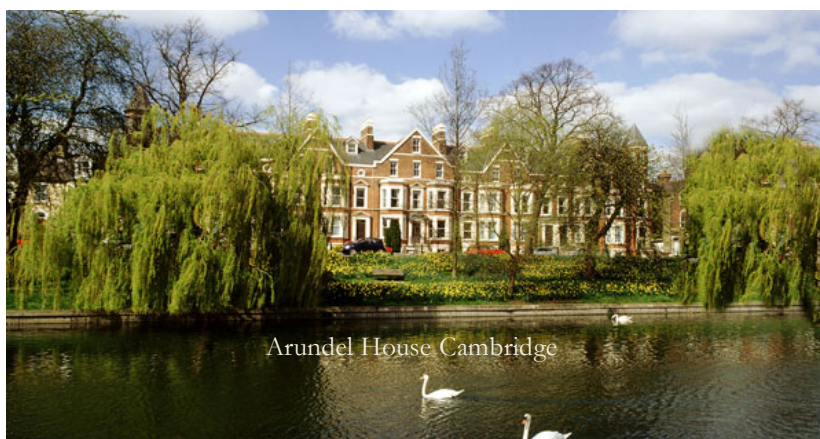

Day 12 – Tuesday, April 4

Transfer via provided motorcoach from hotel to St. Pancras Rail Station for the morning Eurostar train from London to Paris' Gare du Nord Rail Station. Motorcoach pickup at 7:00 am for a 9:24 am departure of Eurostar train at St. Pancras Station. Total train time is 2 hours 42 minutes.

Upon arrival in Paris, guide Anne Marie will begin the Paris panoramic sightseeing tour with private motorcoach, including entrance to Arc de Triomphe, followed by a transfer to the Ronceray Opera Hotel for a four-night stay, with full breakfast included. 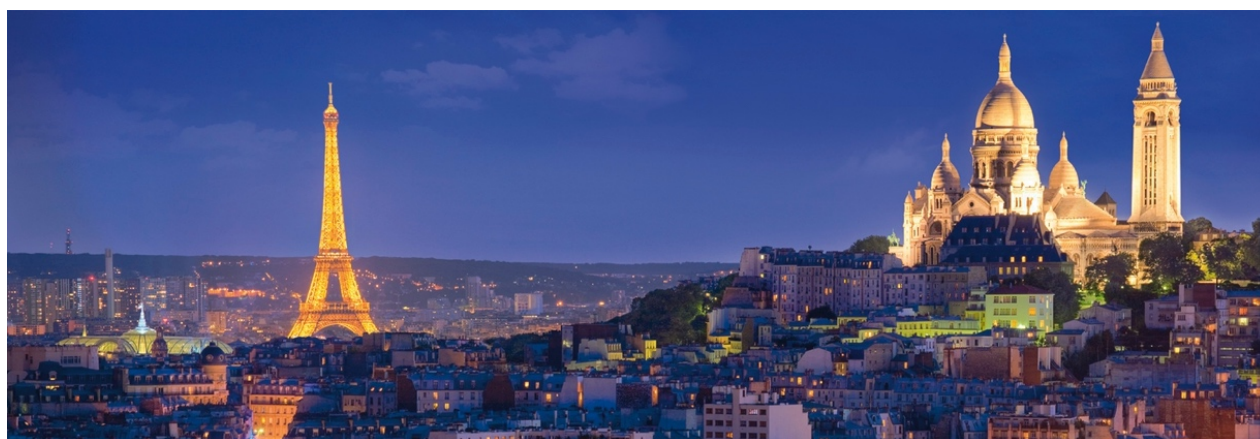
